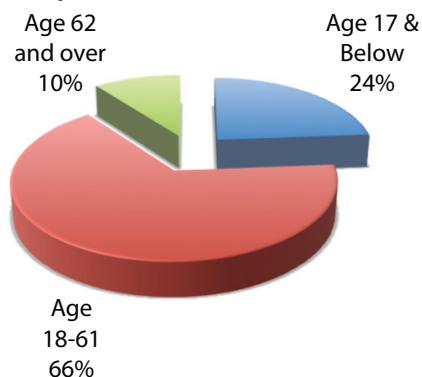

► 2008 estimates from the 2000 U.S. Census reported total population as **75,028**.² The graph on the right indicates the percentage by age group.



SPOTLIGHT ON...

EMPOWERING COMMUNITY LEADERS

Four years ago, the Family & Consumer Science Extension Agent was asked by a local policymaker to help pursue Main Street certification from the Kentucky Heritage Council. Over 130 individuals, 10 groups, 9 businesses, and all 9 City Councilmen supported the effort. With the FCS Agent, six volunteers held 36 meetings, attended seven state Main Street trainings or conferences, and conducted 13 events. Over 40 citizens served on subcommittees and the Main Street Board. The City Council and Mayor hired a Main Street Manager, allocating \$50,000 to the position. Committee members have donated over 7,000 hours valued at \$141,750. Because of this high-visibility Extension programming, the city was awarded \$205,000 for funding sidewalks and beautification.¹



OUR COMMUNITY

► Unemployment rates are a key economic indicator. In July 2010, the rate of unemployment in Bullitt County was **9.3%**.⁶

Mortgage and bank card delinquency rates and foreclosure filings are important financial indicators of community well-being. In Bullitt County, **4.1%** of mortgages are 90-days delinquent and **1.1%** of bank cards are 60-days delinquent.⁷ In a one-year period (August 2009 through August 2010), **455** foreclosures were filed.⁵

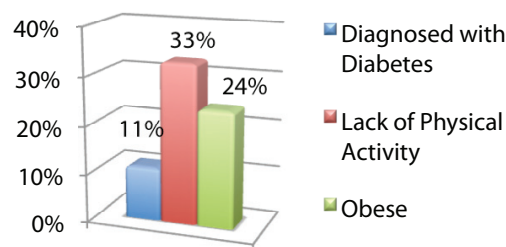
Access to health insurance is another important factor contributing to family well-being. In Bullitt County, **9%** of the people under age 65 are uninsured.⁸

As a result of participation in Bullitt County Extension programs:¹

- **349** people were involved in addressing issues of their community.
- **91** people increased their knowledge of governmental process.
- **193** people expanded their knowledge of economic development.
- Bullitt County Extension is involved in **20** community coalitions.

OUR HEALTH

► The health of our people contributes to quality of life. The chart below illustrates health risks of adults in Bullitt County. **Figure 2. Health Risks.**⁸



As a result of participation in Bullitt County Extension programs:¹

- **923** people increased knowledge of practices to maintain health and well-being.
- **270** people used safe practices to store, handle, and prepare food.
- **414** people made lifestyle changes to improve health.

OUR FAMILIES

► Using data from the 2000 U.S. Census, Bullitt County families can be described as follows:²

- **17,745** families reside in the county.
- **1,110** families (**6.2%**) live below poverty level.
- Median family income is **\$49,481**.
- **575** grandparents are responsible for the care of their grandchildren.



According to the Kentucky Cabinet for Health and Family Services, **2,895** people in Bullitt County receive supplemental nutrition assistance. The average family benefit is **\$267.47** per month.³

In the county, **175** children live in out-of-home care. There were **180**

child victims of substantiated abuse.⁴ There were **181** incidents of adult abuse.⁵

As a result of participation in Bullitt County Extension programs:¹

- **455** adults and youth improved their ability to make informed and effective decisions.
- **246** people increased their knowledge and skills related to parenting and personal relationships.
- **530** adults and youth improved practical living skills.
