OUR FOCUS

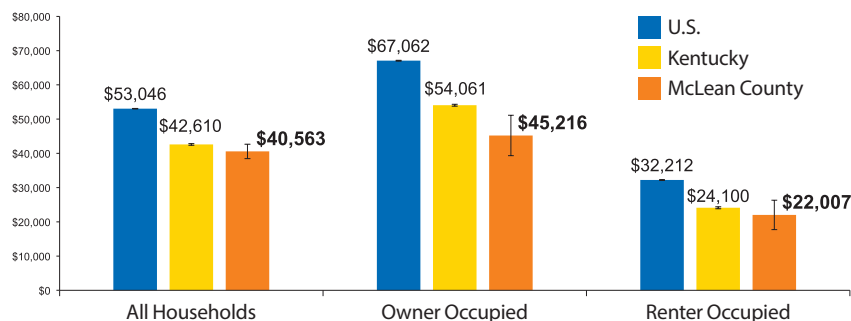
Family and Consumer Sciences Extension is committed to improving the health and well-being of individuals and families in McLean County. To help families make wise decisions, our educational programs focus on:

SPOTLIGHT ON ...

CANNING BASICS

Canning education is a necessity to prevent spoilage and botulism. Botulism can be controlled in home-canned foods if home canners are aware of the dangers and take steps to prevent it. In an effort to minimize the incidence of botulism in home canning, the McLean County Extension agent for Family and Consumer Sciences taught six canning education programs to 43 participants. Among the program's results: 100% of participants learned new techniques and/or skills required to safely preserve canned food; 50% shared their new knowledge with family, a friend or a neighbor. Follow-up evaluations indicated that the participants canned a total of more than 750 jars of produce last year.

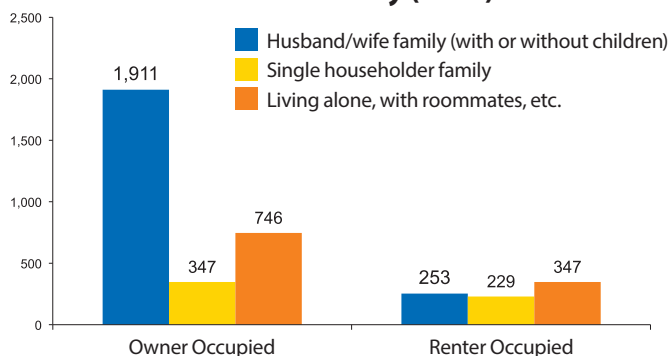
AVAILABILITY

In 2010, in McLean County, there were...³

- **829** renter households
- **3,004** homeowner households
- **79** vacant housing units for rent
- **43** vacant housing units for sale

According to the Kentucky Department of Education, in 2012-2013, **7** children were homeless or were precariously housed in McLean County.⁴

HEALTH AND SAFETY

In McLean County, it is estimated that in 2008-2012...²

- half of all renter-occupied housing was built before **1971** (+/- 4 years)
- half of all owner-occupied housing was built before **1971** (+/- 3 years)

According to 2008-2012 American Community Survey² estimates in McLean County...

- **2.4%** (+/- 1.0) of all households had no landline or cell phone
- **53.7%** (+/- 4.4) of workers living in McLean County worked in Kentucky but outside the county and **4.0%** (+/- 1.8) worked outside the state
- Half of all workers traveled **27.5** (+/- 2.5) or more minutes to work

AFFORDABILITY

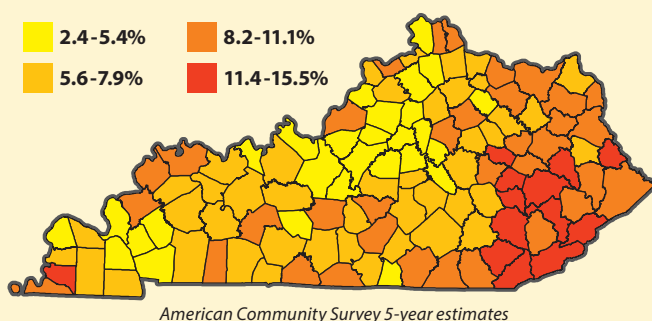
According to American Community Survey estimates for McLean County, in 2008-2012...²

- **36.5%** (+/- 10.9) of renter households paid **35%** or more of their income for rent and utilities
- **16.1%** (+/- 4.5) of homeowner households with a mortgage and **5.3%** (+/- 2.7) of homeowner households without a mortgage paid **35%** or more of their income for housing costs
- **50.8%** (+/- 4.0) of homeowner households did not have a mortgage
- **21.1%** (+/- 3.1) of all housing units were mobile homes

According to the most recent poverty estimates, in 2012, **17.0%** (+/- 3.3) of residents in the county were living below poverty.⁵

In 2013, residents needed to earn **\$12.04** an hour (or work **1.7** jobs at \$7.25 an hour**) to afford a two-bedroom apartment at Fair Market Rent in McLean County.⁶
