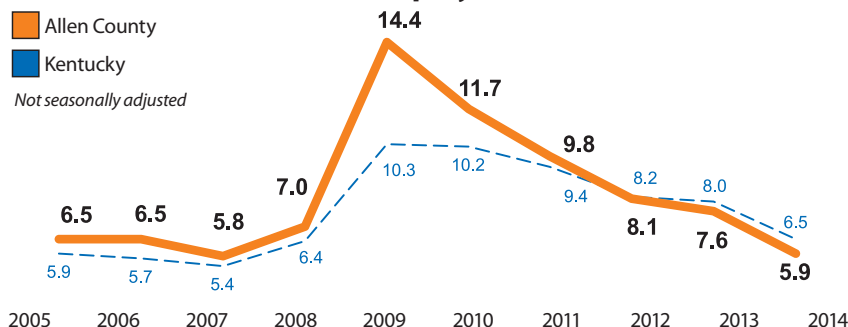
- **Making Healthy Lifestyle Choices** that influence health and well-being

## PERSONALITY IMPACTS MONEY HABITS

**T**hrough a Money Habitudes class, 223 Allen County-Scottsville High School students said they learned how personality traits related to money and how personal relationships with and thoughts about money can build financial literacy and affect financial well-being and other areas of life. Students also identified their personality traits and determined how these traits may affect their financial literacy. In addition, 33 students entered the Kentucky Saves Piggy Bank Design Contest. Six won \$200 cash from sponsors U.S. Bank and the Cooperative Extension Service. One student represented the Mammoth Cave area during the Kentucky Capitol General Assembly bank design display in February 2015.

## FINANCIAL WELL-BEING

In Allen County, the median household income in 2013 was **\$39,798 (+/- \$3,522)** compared to \$43,307 (+/- \$631) for the state.<sup>3</sup>

The American Community Survey estimates that between 2009-2013:<sup>4</sup>

- **21.2% (+/-4.9)** of families with related children were below poverty
- **15.2% (+/-4.0)** of people age 65 and over were below poverty
- **2.3% (+/-1.4)** of individuals working full time/full year in the previous 12 months were below poverty
- **57.7%** of students were eligible for free lunches and **6.4%** were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

### As a result of participating in Allen County Extension programs:<sup>1</sup>

- **815** people demonstrated informed and effective decision-making.
- **590** people demonstrated increased practical living skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Allen County in 2012:<sup>6</sup>

- **12.0% (15.6%-9.1%)** of adults reported having been diagnosed with diabetes
- **35.0% (42.1%-28.7%)** of adults 18 years and over were obese
- **34.0% (41.1%-27.1%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Allen County:<sup>7</sup>

- **31.9% (45.1%-21.1%)** of adults reported having been diagnosed with high blood pressure
- **23.1% (30.2%-17.3%)** of adults reported fair or poor health

In Allen County:

- **41.8%** had adequate access to locations for physical activity compared to 72.0% for the state<sup>8</sup>
- **39.0% (+/-6.1)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)<sup>8</sup>
- **20** deaths were from a drug overdose between 2009-2013<sup>9</sup>

### As a result of participating in Allen County Extension programs:<sup>1</sup>

- **6,375** people increased knowledge of lifestyle changes to improve personal health.
- **22** children and youth learned to eat more healthy food.

## SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Allen County:<sup>4</sup>

- **27.2% (+/-1.3)** of households included one or more persons age 65 and over
- **288 (+/-153)** grandparents lived with and were responsible for their own grandchildren
- **65.7% (+/-12.8)** of children under 6 years and **66.2% (+/-7.3)** of children 6-17 years had all parents in the labor force
- **991 (+/-398)** of those age 5 and older spoke a language other than English at home
- **1,508 (+/-223)** civilian veterans lived in Allen County<sup>4</sup>

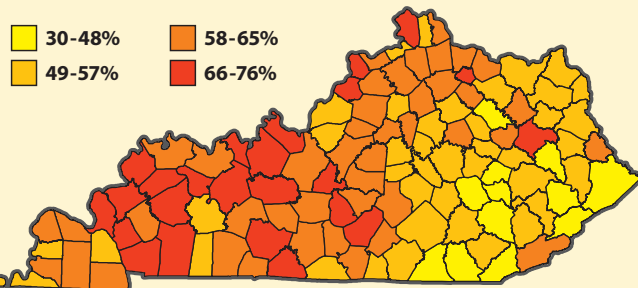
In Allen County:

- **17.2% (25.4%-11.2%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12<sup>7</sup>
- **104** children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- **49.0%** of those registered to vote did so in the 2014 General Election<sup>11</sup>

### As a result of participating in Allen County Extension programs:<sup>1</sup>

- **163** adults reported increased leadership skills, knowledge or confidence.
- **6,233** people were reached with information related to health and safety.
