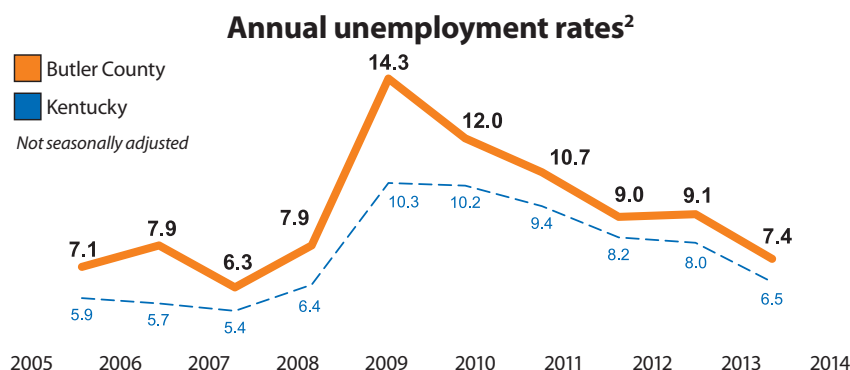
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Butler County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being

In 2014-2015, Family and Consumer Sciences Extension made **3,503** contacts with Butler County individuals and families.¹

SPOTLIGHT ON...

DIABETES HEALTH FAIR IN ITS 7TH YEAR

A diabetes health fair organized by the FCS agent and other local agencies is in its seventh year. Through the years, the fair has grown; today it offers blood screenings, one-on-one meetings with the pharmacist and doctor, blood pressure screenings, and fitness information. The FCS agent provides educational displays and pamphlets, healthy snacks, and does one-on-one informational sessions. More than 200 individuals have participated. In evaluations, 72% said the information helped them manage their diabetes, 90% have developed a rapport with their pharmacist so they could discuss their diabetes, and 98% know their numbers.

FINANCIAL WELL-BEING

In Butler County, the median household income in 2013 was **\$36,670 (+/- \$3,436)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **26.2% (+/-6.9)** of families with related children were below poverty
- **24.2% (+/-6.7)** of people age 65 and over were below poverty
- **5.0% (+/-3.0)** of individuals working full time/full year in the previous 12 months were below poverty
- **54.8%** of students were eligible for free lunches and **5.4%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Butler County Extension programs:¹

- **150** people demonstrated informed and effective decision-making.
- **315** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Butler County in 2012:⁶

- **14.0% (18.3%-10.5%)** of adults reported having been diagnosed with diabetes
- **35.5% (42.9%-28.6%)** of adults 18 years and over were obese
- **36.5% (44.6%-28.9%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Butler County:⁷

- **30.3% (44.6%-18.9%)** of adults reported having been diagnosed with high blood pressure
- **22.6% (31.7%-15.6%)** of adults reported fair or poor health

In Butler County:

- **30.6%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **43.2% (+/-7.5)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **15** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Butler County Extension programs:¹

- **820** people increased knowledge of lifestyle changes to improve personal health.
- **1,575** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Butler County:⁴

- **29.4% (+/-1.9)** of households included one or more persons age 65 and over
- **165 (+/-89)** grandparents lived with and were responsible for their own grandchildren
- **51.6% (+/-12.1)** of children under 6 years and **59.2% (+/-10.4)** of children 6-17 years had all parents in the labor force
- **347 (+/-129)** of those age 5 and older spoke a language other than English at home
- **802 (+/-147)** civilian veterans lived in Butler County⁴

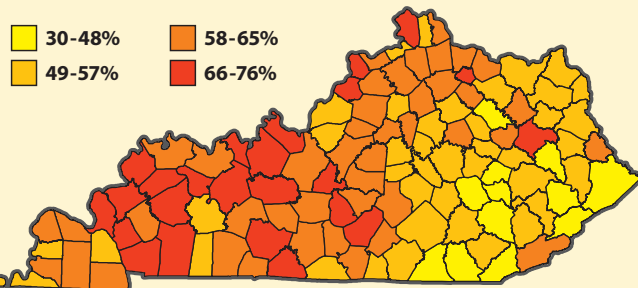
In Butler County:

- **17.7% (26.7%-11.3%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **51** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **45.4%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Butler County Extension programs:¹

- **197** adults reported increased leadership skills, knowledge or confidence.
- **575** people were reached with information related to health and safety.
