OUR FOCUS

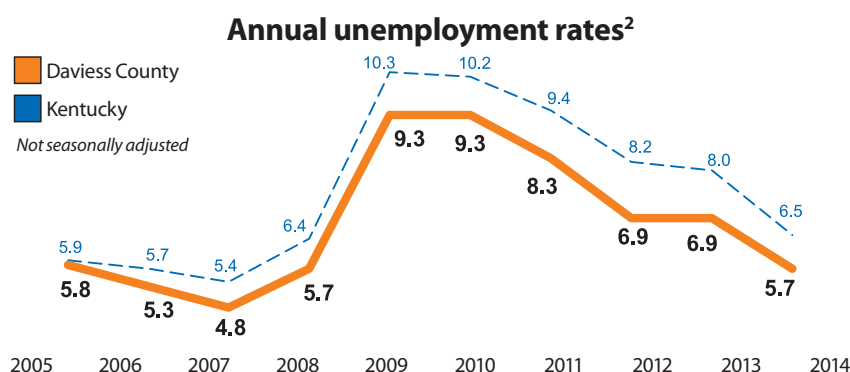

SPOTLIGHT ON...

FINANCIAL MANAGEMENT BASICS

Many families in Daviess County have faced the challenges of addiction. When addiction is a problem, families also often deal with abuse, strained family relationships, and financial hardships. Finding employment and being financially secure are essential to recovery. To share basic financial management skills, the Daviess County Extension Office partnered with Lighthouse Recovery Services on a five-session Financial Management Basics program. Evaluation results show all participants learned more and plan to use the knowledge to change their behavior and make better financial decisions. One participant said, "Money Habitudes helped me recognize my inability to handle money and where I need to improve."

FINANCIAL WELL-BEING

In Daviess County, the median household income in 2013 was **\$46,908 (+/- \$2,563)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **20.4%** (+/-**2.4**) of families with related children were below poverty
- **10.2%** (+/-**1.8**) of people age 65 and over were below poverty
- **2.7%** (+/-**0.9**) of individuals working full time/full year in the previous 12 months were below poverty
- **51.0%** of students were eligible for free lunches and **7.5%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Daviess County Extension programs:¹

- **286** people demonstrated informed and effective decision-making.
- **650** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Daviess County in 2012:⁶

- **10.7%** (**12.4%-9.2%**) of adults reported having been diagnosed with diabetes
- **28.8%** (**32.1%-25.8%**) of adults 18 years and over were obese
- **25.2%** (**28.1%-22.3%**) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Daviess County:⁷

- **33.6%** (**38.7%-28.8%**) of adults reported having been diagnosed with high blood pressure
- **19.7%** (**22.5%-17.2%**) of adults reported fair or poor health

In Daviess County:

- **69.7%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **15.4%** (+/-**1.5**) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **74** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Daviess County Extension programs:¹

- **3,653** people increased their knowledge of healthy food consumption.
- **375** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Daviess County:⁴

- **26.9%** (+/-**0.7**) of households included one or more persons age 65 and over
- **1,107** (+/-**249**) grandparents lived with and were responsible for their own grandchildren
- **69.0%** (+/-**5.2**) of children under 6 years and **69.8%** (+/-**3.5**) of children 6-17 years had all parents in the labor force
- **3,101** (+/-**440**) of those age 5 and older spoke a language other than English at home
- **7,461** (+/-**470**) civilian veterans lived in Daviess County⁴

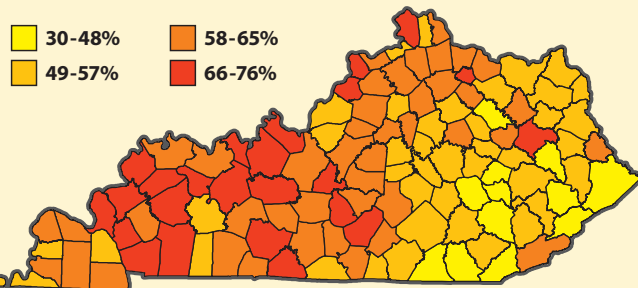
In Daviess County:

- **16.9%** (**20.4%-13.9%**) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **594** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **46.8%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Daviess County Extension programs:¹

- **764** adults reported increased leadership skills, knowledge or confidence.
- **558** people were reached with information related to health and safety.
