OUR FOCUS

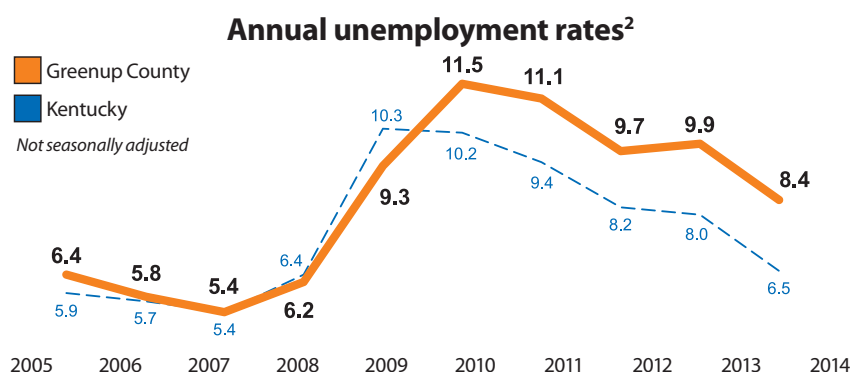

SPOTLIGHT ON...

SUBSTANCE ABUSE HAS CONSEQUENCES

Substance abuse is an epidemic in Greenup County. As part of the Truth and Consequences program, the Greenup County Cooperative Extension agents for 4H and FCS partnered with the Raceland Worthington School District, Greenup County Health Department, Our Lady of Bellefonte Hospital, Pathways, Kentucky State Police, and various community officials on a substance abuse prevention program for freshmen at Raceland Worthington High School. The program emphasized the long-term health effects of substance abuse and how legal consequences can negatively affect the future. In a survey, 94% of the 74 participants said they better understood the legal and health consequences of substance abuse.

FINANCIAL WELL-BEING

In Greenup County, the median household income in 2013 was **\$44,581 (+/- \$3,272)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **20.7% (+/-3.7)** of families with related children were below poverty
- **11.9% (+/-2.2)** of people age 65 and over were below poverty
- **3.3% (+/-1.2)** of individuals working full time/full year in the previous 12 months were below poverty
- **48.8%** of students were eligible for free lunches and **5.0%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Greenup County Extension programs:¹

- **160** people demonstrated informed and effective decision-making.
- **4,064** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Greenup County in 2012:⁶

- **13.7% (16.1%-11.5%)** of adults reported having been diagnosed with diabetes
- **38.4% (42.7%-34.1%)** of adults 18 years and over were obese
- **32.1% (36.1%-28.3%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Greenup County:⁷

- **35.9% (42.1%-30.2%)** of adults reported having been diagnosed with high blood pressure
- **26.4% (30.0%-23.0%)** of adults reported fair or poor health

In Greenup County:

- **67.6%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **30.2% (+/-3.8)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **48** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Greenup County Extension programs:¹

- **568** people increased knowledge of lifestyle changes to improve personal health.
- **2,072** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Greenup County:⁴

- **30.8% (+/-0.8)** of households included one or more persons age 65 and over
- **866 (+/-234)** grandparents lived with and were responsible for their own grandchildren
- **67.6% (+/-5.3)** of children under 6 years and **63.2% (+/-6.0)** of children 6-17 years had all parents in the labor force
- **503 (+/-135)** of those age 5 and older spoke a language other than English at home
- **2,765 (+/-265)** civilian veterans lived in Greenup County⁴

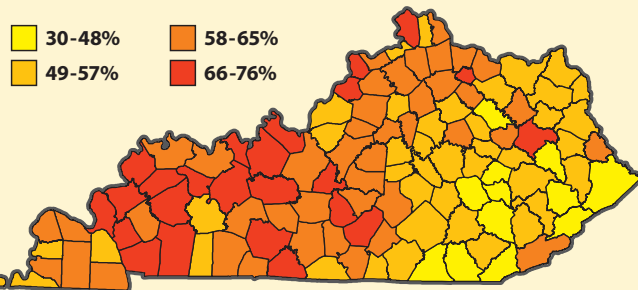
In Greenup County:

- **18.0% (22.4%-14.3%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **232** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **41.7%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Greenup County Extension programs:¹

- **500** adults reported increased leadership skills, knowledge or confidence.
- **160** people were reached with information related to health and safety.
