OUR FOCUS

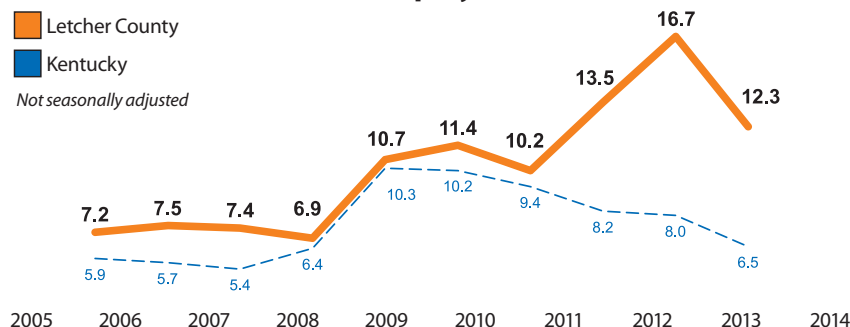
Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Letcher County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being
- **Nurturing Families** as they cope with fewer resources and more demands
- **Embracing Life as We Age** to live independently longer
- **Securing Financial Stability** in a turbulent economic period
- **Promoting Healthy Homes and Communities** that recycle, reduce waste, and protect our environment

In 2014-2015, Family and Consumer Sciences Extension made **13,000** contacts with Letcher County individuals and families.¹

SPOTLIGHT ON...

GROWING GOOD NUTRITION AND HEALTH

The FCS/SNAP-Ed Staff have shared MyPlate curriculum and Plate It Up! Kentucky Proud recipes with residents, many who live in poverty, through Head Start parent groups, senior citizen centers, the farmers' market, summer youth day camps, school groups, and with NEP program families. At the Letcher County Farmers' Market this season, they provided information about nutrition, health, and home food preservation on five Saturdays and one Wednesday evening. Approximately 225 families visited the booths. One of the Saturdays a health fair was offered, cosponsored by the farmers' market and Mountain Comprehensive Health Corporation.

FINANCIAL WELL-BEING

In Letcher County, the median household income in 2013 was **\$31,799 (+/- \$2,832)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **28.8% (+/-6.4)** of families with related children were below poverty
- **17.6% (+/-4.6)** of people age 65 and over were below poverty
- **2.8% (+/-1.3)** of individuals working full time/full year in the previous 12 months were below poverty
- **65.9%** of students were eligible for free lunches and **6.1%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Letcher County Extension programs:¹

- **50** people demonstrated informed and effective decision-making.
- **300** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Letcher County in 2012:⁶

- **15.4% (18.4%-12.7%)** of adults reported having been diagnosed with diabetes
- **37.9% (43.0%-33.2%)** of adults 18 years and over were obese
- **34.6% (39.7%-29.6%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Letcher County:⁷

- **44.1% (51.4%-37.1%)** of adults reported having been diagnosed with high blood pressure
- **30.5% (35.0%-26.3%)** of adults reported fair or poor health

In Letcher County:

- **57.8%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **38.2% (+/-7.2)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **61** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Letcher County Extension programs:¹

- **18** people increased knowledge of lifestyle changes to improve personal health.
- **400** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Letcher County:⁴

- **28.4% (+/-1.4)** of households included one or more persons age 65 and over
- **699 (+/-248)** grandparents lived with and were responsible for their own grandchildren
- **31.4% (+/-9.0)** of children under 6 years and **52.4% (+/-7.9)** of children 6-17 years had all parents in the labor force
- **212 (+/-101)** of those age 5 and older spoke a language other than English at home
- **1,277 (+/-209)** civilian veterans lived in Letcher County⁴

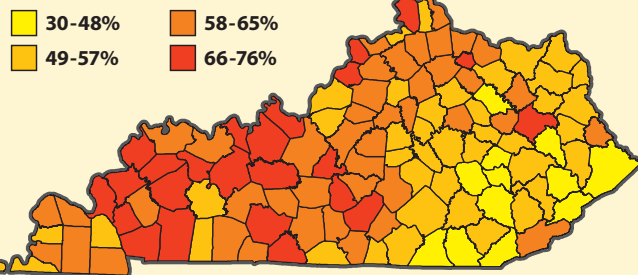
In Letcher County:

- **23.4% (29.6%-18.1%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **217** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **47.8%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Letcher County Extension programs:¹

- **359** adults reported increased leadership skills, knowledge or confidence.
- **200** people were reached with information related to health and safety.
