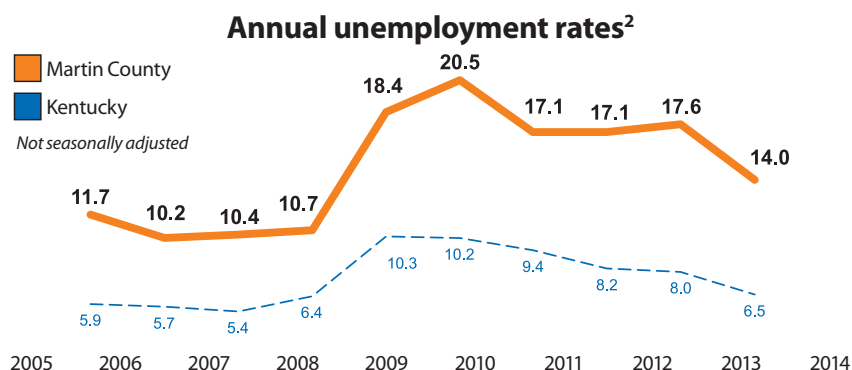
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Martin County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being
- **Nurturing Families** as they cope with fewer resources and more demands
- **Embracing Life as We Age** to live independently longer
- **Securing Financial Stability** in a turbulent economic period
- **Promoting Healthy Homes and Communities** that recycle, reduce waste, and protect our environment

- **Empowering Community Leaders** as we all work to sustain and improve our communities

In 2014-2015, Family and Consumer Sciences Extension made **4,468** contacts with Martin County individuals and families.¹

SPOTLIGHT ON...

HEALTHY EATING CLASSES COMBAT OBESITY

Kentucky is in the top 10 among states in terms of obesity, and Kentucky adults rank among the worse for not eating enough fruits and vegetables. Nutrition education programs are part of the Extension FCS agent's plan. Thirty people attended a series on healthy eating that included sessions on Healthy Eating on a Budget, Healthy Eating on the Run, and Healthy Eating to Slim Down. Participants learned to make changes in their diet to eat healthier. All participants said they have a better understanding of healthy eating, food safety, and better food choices for on the go.

FINANCIAL WELL-BEING

In Martin County, the median household income in 2013 was **\$26,931 (+/- \$2,482)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **54.4% (+/-8.3)** of families with related children were below poverty
- **10.0% (+/-4.0)** of people age 65 and over were below poverty
- **4.2% (+/-2.6)** of individuals working full time/full year in the previous 12 months were below poverty
- **69.0%** of students were eligible for free lunches and **2.9%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Martin County Extension programs:¹

- **899** people utilized skills learned through Extension programming.
- **100** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Martin County in 2012:⁶

- **13.6% (17.4%-10.2%)** of adults reported having been diagnosed with diabetes
- **40.7% (47.6%-34.0%)** of adults 18 years and over were obese
- **32.7% (40.1%-26.5%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Martin County:⁷

- **40.1% (52.6%-28.9%)** of adults reported having been diagnosed with high blood pressure
- **38.2% (47.2%-30.0%)** of adults reported fair or poor health

In Martin County:

- **61.2%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **55.4% (+/-12.2)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **35** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Martin County Extension programs:¹

- **1,060** people increased knowledge of lifestyle changes to improve personal health.
- **328** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Martin County:⁴

- **24.6% (+/-2.2)** of households included one or more persons age 65 and over
- **373 (+/-186)** grandparents lived with and were responsible for their own grandchildren
- **24.6% (+/-14.4)** of children under 6 years and **31.5% (+/-9.2)** of children 6-17 years had all parents in the labor force
- **348 (+/-132)** of those age 5 and older spoke a language other than English at home
- **645 (+/-152)** civilian veterans lived in Martin County⁴

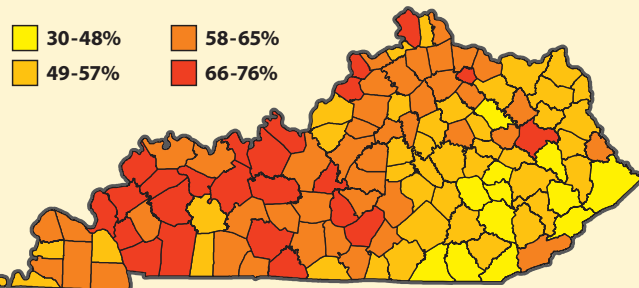
In Martin County:

- **29.6% (40.7%-20.6%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **124** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **47.8%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Martin County Extension programs:¹

- **1,460** adults reported increased leadership skills, knowledge or confidence.
- **328** people were reached with information related to health and safety.
