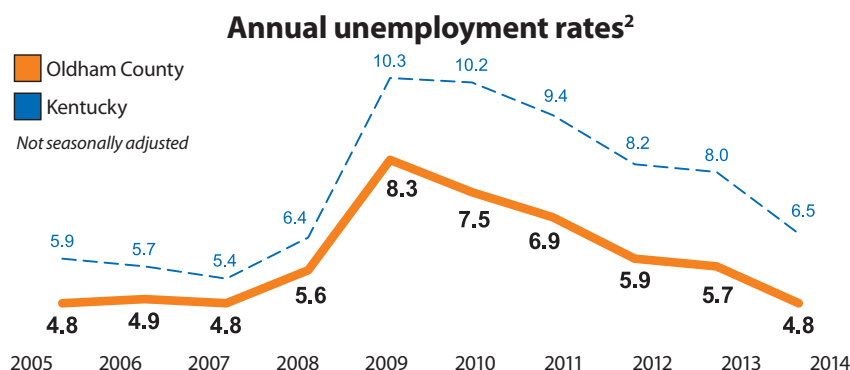
OUR FOCUS

SPOTLIGHT ON...

CANNING INFORMATION SPREAD BY SOCIAL MEDIA

As interest has increased in local food and home gardening, the demand for safe canning information has risen. The FCS agent taught several canning programs and encouraged participants to enter their canning in the county fair. Because of the increase in canning entries, the county judge executive asked that the program be aired on local access TV and YouTube. More than 200 residents watched the video or attended classes. Responses indicated that because of the information distributed, all attendees learned the importance of following USDA recommendations and instructions for canning and using pressure canners for low-acid foods.

FINANCIAL WELL-BEING

In Oldham County, the median household income in 2013 was **\$86,580 (+/- \$5,438)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **8.6% (+/-2.1)** of families with related children were below poverty
- **3.5% (+/-1.8)** of people age 65 and over were below poverty
- **1.0% (+/-0.3)** of individuals working full time/full year in the previous 12 months were below poverty
- **17.4%** of students were eligible for free lunches and **3.0%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Oldham County Extension programs:¹

- **1,897** people demonstrated informed and effective decision-making.
- **2,097** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Oldham County in 2012:⁶

- **10.4% (13.5%-7.8%)** of adults reported having been diagnosed with diabetes
- **30.1% (36.0%-24.7%)** of adults 18 years and over were obese
- **22.5% (27.7%-17.7%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Oldham County:⁷

- **26.5% (38.6%-17.1%)** of adults reported having been diagnosed with high blood pressure
- **7.9% (12.7%-4.9%)** of adults reported fair or poor health

In Oldham County:

- **85.3%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **42.4% (+/-2.7)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **25** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Oldham County Extension programs:¹

- **1,200** people increased knowledge of lifestyle changes to improve personal health.
- **514** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Oldham County:⁴

- **21.0% (+/-0.7)** of households included one or more persons age 65 and over
- **305 (+/-113)** grandparents lived with and were responsible for their own grandchildren
- **72.1% (+/-5.4)** of children under 6 years and **71.4% (+/-3.1)** of children 6-17 years had all parents in the labor force
- **3,226 (+/-391)** of those age 5 and older spoke a language other than English at home
- **4,487 (+/-366)** civilian veterans lived in Oldham County⁴

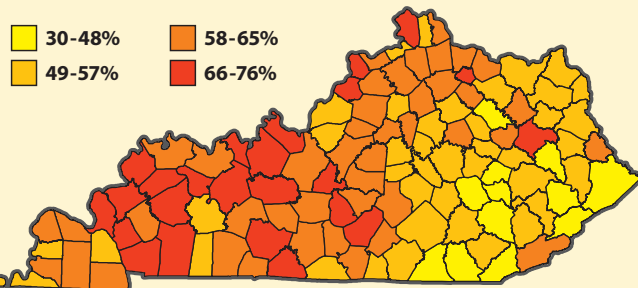
In Oldham County:

- **8.9% (14.4%-5.4%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **59** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **50.2%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Oldham County Extension programs:¹

- **1,593** adults reported increased leadership skills, knowledge or confidence.
- **120** people were reached with information related to health and safety.
