

OUR COUNTY

- McCreary County had 3 supermarkets and other grocery stores and 13 convenience stores or gas stations with convenience stores in 2015.3
- According to Map the Meal Gap, in 2015, an estimated
 3,960 individuals
 were food insecure in McCreary County.⁴
- Only 5.3% (13.3%-2.0%)
 of adults in McCreary County
 consumed five or more
 servings of fruits and
 vegetables per day
 between 2013-2015.5

OUR RESULTS

- 25 individuals were exposed to Extension programming at a local farmers market.¹
- **\$50,000** in funding has been received by community health coalitions.¹



Physical Environment

OUR COUNTY

- According to the CDC's County Diabetes Atlas,
 34.3% (40.3%-28.3%) of adults 18 years and over in McCreary County were obese between 2012 and 2014.6
- The Diabetes Atlas also reports that between 2012 and 2014, **30.4%** (**36.7%-24.4%**) of adults in McCreary County reported no leisure-time exercise in the past month.⁶
- There were no fitness and recreation businesses in McCreary County in 2015.3



of the population in McCreary County had adequate access to locations for physical activity in 2014.⁷

OUR RESULTS

- **50** individuals adopted physical activity practices.¹
- 50 individuals demonstrated that they had spent time being physically active.¹



OUR COUNTY

- The median household income in McCreary County was **\$25,655** (**\$28,276-\$23,034**) in 2015.8
- In McCreary County, 788
 was the average monthly
 number of infants and children
 assisted by WIC* in 2013.9
- In 2015, there were **5,975** SNAP/ food stamp recipients.¹⁰
- 25.2% (+/-10.1%) of people age 65 and over were below poverty between 2011-2015¹¹ and 48.6% (60.3%-36.9%) of children ages 5-17 in families were below poverty in 2015.8
- Between 2011 and 2015, 12.0% (+/-4.9%) of full-time/full-year workers were below poverty.¹¹



of all children in McCreary County ages 17 and under¹² were below poverty in 2015.8




